

FACTS	WHAT DOES BHCU DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number and transaction history account balances and checking account information credit history and credit scores When you are <i>no longer</i> our member, we continue to share your information as described in this notice.
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons BHCU chooses to share; and whether you can limit this sharing.

How does BHCU protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does BHCU collect my personal	We collect your personal information, for example, when you

Why can't I limit all sharing?	Federal law gives you the right to limit only

	State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account—unless you tell otherwise.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
	Nonaffiliates we share with can include insurance companies, government agencies, plastic card processor (credit/debit/ATM), financial statement publishers or printers, consumer reporting agencies, mailhouses, data processors, check/share draft printers and Haddon Planning Group.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
	 Our joint marketing partners include CUNA Mutual Group's MEMBERCONNECT and Haddon Planning Group.
